

## Conditions for contract work in 2026

1. We accept contract work on the basis of the following conditions. A service sheet is issued showing the duration of the work and the use of vehicles and equipment. This must be signed by the client or the client's agent.
2. This work is charged at the following hourly rates:

- 2.1 The contract rates include the cost of tools and additional costs of board and lodging.
- 2.2 For up to 8 hours of work by a fitter, chief erector or service technician we charge an additional hour at the rate for an assembly foreman/customer service foreman. For more than 8 hours of work the services of our assembly and customer service foremen are charged on a pro rata basis.
- 2.3 Travelling times (to and from the site) and waiting times for which we are not responsible are charged at the rates set out in paragraph 2.
3. For working hours in excess of the normal, collectively agreed working time we charge the following supplements:
  - Additional work of more than 8 hours 25 %
  - Night work from 20.00 hours to 6.00 hours 50 %
  - Work on Saturdays from 0.00 hours to 24.00 hours 50 %
  - Work on Sundays from 0.00 hours to 24.00 hours 100 %
  - Work on statutory public holidays 100 %

The basis of calculation are the contract rates set out in paragraph 2 less 15 %.

4. We charge an additional flat rate per emergency service.  
 For customers: with maintenance contract as well as with agreement "annual emergency service flat rate" 0.00 EUR  
 with maintenance contract but without agreement "Annual emergency service flat rate" 295.00 EUR  
 without maintenance contract but with agreement "Annual emergency service flat rate" 295.00 EUR  
 without maintenance contract and without agreement "Annual emergency service flat rate" 495.00 EUR

5. Vehicles and equipment are charged for in addition at the following rates:

6. Unless otherwise agreed, the material will be charged for at daily rates on the basis of a record of material used. Any other services that become necessary such as technical handling, acceptance tests, coordination, documentation etc. will be charged for in addition.
7. Our invoices for contract services are due for payment immediately without any deductions.
8. The prices set out above are quoted exclusive of statutory value added tax.
9. **Special conditions apply in the case of work outside the Federal Republic of Germany.**
10. We explicitly reserve the right to change these conditions at any time, particularly the cost items.  
 The place of performance for payments is Minden. The place of jurisdiction is Bad Oeynhausen.
